**A**S A CONSUMER OF HEALTH SERVICES, you should receive competent and ethical care every time you use the services of a health care professional. If you feel your care was not delivered in a professional and appropriate manner, or with your best interest in mind, you have a right to speak out. The following information may help you decide your course of action.

## Self-Regulating Professions

**I**n Saskatchewan, there are 27 health-related professions with the authority to regulate their profession. Saskatchewan Health and the Network of Interprofessional Regulatory Organizations (NIRO) are committed to ensuring that people are well served and protected from any risk of harm. Licensing and regulating health professions assures an accountability by:

- ensuring that the health professional is qualified to practise;
- setting standards of practice and a code of ethics that the health professional must follow;
- requiring the health professionals to be registered and licensed to use the title of the profession and/or perform certain services; and
- investigating complaints/reports about the professional and taking corrective and or disciplinary action if necessary.

## Concerns about a Regulated Health Professional

**I**f you have concerns about the conduct of a health professional, you may want to consider the options below.

- Discuss the problem directly with the health professional involved. Concerns may result from a misunderstanding or inadequate communication between the consumer and the health professional.
- Speak with the health professional's supervisor or an agency representative.
- Contact the Quality of Care Coordinator or Client Representative within the regional health authority (RHA) where care was received (listed in this brochure). The Quality of Care Coordinator or Client Representative assists individuals and/or families to address concerns about the health services in their region; ensure individuals are informed about their rights and options; and recommends changes or improvements to enhance the quality of health services delivered in the region based on their findings and trends of concerns raised.
- Contact Ombudsman Saskatchewan (listed in this brochure), for complaints of unfairness in provincial government ministries and agencies (including the Ministry of Health, the Saskatchewan Cancer Agency and local health regions).
- Contact the appropriate regulatory body (listed in this brochure).

## Submitting a Formal Complaint/Report with a Regulatory Organization

**W**hen considering submission of a formal complaint/report, it is important to discuss the matter with a representative of the appropriate regulatory organization. The representative will provide you with direction regarding the process for submitting a complaint/report.

Upon receiving a formal complaint/report, a regulatory organization will review and consider the complaint/report and determine whether a formal inquiry should be conducted. Regulatory organizations will advise you of the outcome of your complaint/report.

If the professional is found to have acted inappropriately or incompetently, the organization may suggest mediation or alternative dispute resolution, issue a reprimand or letter of guidance/caution, require a period of supervised practice, levy a fine, or suspend or terminate the member's right to practise. Action taken by a regulatory organization or an employer does not prevent a client from seeking legal action, through the courts, against the health professional.

Regulatory organizations do not have the authority to order compensation for you. Compensation may only be awarded by the courts in response to a lawsuit filed against a health professional or the employer of a health professional.
